

June Meeting

June 9, 2025

The Wheeler Central Board of Education Regular Board Meeting was held June 9, 2025. Chairperson Swick called the meeting to order at 9:02 a.m. and pointed out the location of the Open Meetings Act poster. The roll was called with the following Board members present: Andrew Smith, Dennis Derner, Jessie Swick, Zach Wright, Drew Kasselder, and Sydney McKay. Also present were Dan Kluver and Makayla Reiter.

The pledge of allegiance was recited.

Wright made the motion to approve the consent agenda as presented. Seconded by Kasselder. Roll call vote: Smith - aye, Wright - aye, Derner - aye, Kasselder - aye, Swick - aye, and McKay - aye.

Chairperson Swick welcomed the visitors and opened the floor for public comment. No public comment was held at this time.

No Staff Report given.

Principal Reiter gave the PK-12 Principal report.

Superintendent Kluver gave the Superintendent report.

During the Board Report, Wilkins Architects went over the facility audit.

Smith made a motion to approve the Country Bliss Flooring quote for \$5,667 to install new carpet in the Media Center. Seconded by McKay. Roll call vote: Smith - aye, Wright - aye, Derner - aye, Kasselder - aye, Swick - aye, and McKay - aye.

Kasselder made a motion to approve the revision on policy 6004 with the addition of the discussed review calendar. Seconded by McKay. Roll call vote: Smith - aye, Wright - aye, Derner - aye, Kasselder - aye, Swick - aye, and McKay - aye.

Policies 6001, 6010, 6013, 6020, and 6021 were reviewed with no changes needed.

Kasselder made a motion to approve the revision on policy 4030 to remove the requirement of yearly evaluations on permanent certificated staff and move it to a three year schedule. Also to add quarter classroom walkthrough reviews. Seconded by McKay. Roll call vote: Smith - aye, Wright - aye, Derner - aye, Kasselder - aye, Swick - aye, and McKay - aye.

Wright made a motion to approve the 2y Discovery Ed science curriculum for \$14,122.

Seconded by Kasselder. Roll call vote: Smith - aye, Wright - aye, Derner - aye, Kasselder - aye, Swick - aye, and McKay - aye.

Kasselder made a motion to approve the Step Up To Writing curriculum for \$9,653.60.

Seconded by McKay. Roll call vote: Smith - aye, Wright - aye, Derner - aye, Kasselder - aye, Swick - aye, and McKay - aye.

The Title I curriculums were tabled.

Kasselder made a motion to increase the Substitute Teacher Rates to \$135 per day. Seconded by Smith. Roll call vote: Smith - aye, Wright - aye, Derner - aye, Kasselder - aye, Swick - aye, and McKay - aye.

A hearing was opened at 11:48 a.m. for Board Policy 5018 - Parental Involvement. The updates to the policy were reviewed. The floor was opened for public comment. No public comment was held. Kasselder made a motion to approve the revision of policy 5018 with the updates supplied by KSB. Seconded by Wright. Roll call vote: Smith - aye, Wright - aye, Derner - aye, Kasselder - aye, Swick - aye, and McKay - aye. Hearing was closed at 11:51 a.m.

A hearing was opened at 11:51 a.m. for Board Policy 5045 - Student Fees. The updates to the policy were reviewed. The floor was opened for public comment. No public comment was held. Wright made a motion to approve the revision of policy 5045 with the increase of 5 cents for K-12 breakfast and 10 cents for K-12 lunch. Also adult breakfast will increase by 10 cents and adult lunch will increase by 20 cents. Seconded by Derner. Roll call vote: Smith - aye, Wright - aye, Derner - aye, Kasselder - aye, Swick - aye, and McKay - aye. Hearing was closed at 11:54 a.m.

A hearing was opened at 11:54 a.m. for Board Policy 5057 - Student Fees. The policy was reviewed. The floor was opened for public comment. No public comment was held. Hearing was closed at 11:55 a.m.

Smith made a motion to approve the revision on policy 5015 with the updates given from KSB. Seconded by Wright. Roll call vote: Smith - aye, Wright - aye, Derner - aye, Kasselder - aye, Swick - aye, and McKay - aye.

Kasselder made a motion to approve the wrestling COOP with Riverside for the '25-'26 and '26-'27 school years. Seconded by McKay. Roll call vote: Smith - aye, Wright - aye, Derner - nay, Kasselder - aye, Swick - aye, and McKay - aye.

Smith made a motion to approve the hiring of Paul Nordhues to fill the K-12 PE position. Seconded by Wright. Roll call vote: Smith - aye, Wright - aye, Derner - aye, Kasselder - aye, Swick - aye, and McKay - aye.

Wright made a motion to adjourn the meeting, Seconded by Kasselder. All in favor. The meeting was adjourned at 12:05 p.m.
